The grant of performance rights is pursuant to the terms of the Emeco Holdings Limited Long Term Incentive Plan and Rules.

No payment is required on grant or exercise of the performance right.

Each performance right is a right to acquire one fully paid Emeco ordinary share, subject to satisfaction of the performance condition which is based on TSR (total shareholder return).

The performance rights may vest when the performance period ends on the 20th trading date after the announcement of Emeco's annual results in 2016. Any performance rights which vest will automatically be converted into ordinary Emeco shares.


