Results of Annual General Meeting held on 14 November 2019

In accordance with ASX listing rule 3.13.2 and section 251AA(2) of the Corporations Act, we advise that Resolutions 1, 2 and 3, which were put to the shareholders at the Annual General Meeting today, were passed by way of poll.

Resolution 4 (conditional spill resolution) was subject to and conditional upon at least 25% of the votes cast on Resolution 3 (adoption of remuneration report) being cast against that resolution. As Resolution 3 received more than 85% of votes in favour of the resolution, although Resolution 4 was ultimately not required, it was defeated by way of poll.

Details of the votes cast in respect of each resolution is detailed in the attached annexure.
