The grant of these performance rights is pursuant the terms of the Emeco Holdings Limited Employee Incentive Plan Rules. The issue was approved by shareholders at the Annual General Meeting held 14 November 2019

No payment is required from the participant on grant or vesting of the performance rights.

Each performance right is a right to one fully paid Emeco ordinary share, subject to satisfaction of the service condition which requires the participant to remain with the Emeco Group until the end of the performance period.

Performance rights may vest when the performance period ends, being the date following the release of the full year results in 2020.

For performance rights which vest, ordinary Emeco shares will be issued and/or transferred to the participant.

Any performance rights in respect of which the service condition is not satisfied as at the end of the performance period will lapse.

Performance rights may lapse earlier in certain circumstances of cessation of employment and due to forfeiture. If the participant leaves employment due to death, total and permanent disability, retrenchment or retirement, then the performance rights will vest on the termination date pro-rated based on the period employed with the Emeco Group during the performance period. The performance rights may also vest if the participant leaves the Emeco Group prior to the vesting date for any other reason, at the Board's discretion.
